Important Information-Please Reply

The Federal Communication Commission published its final rule changes on unsolicited faxes under the Telephone Consumer Protection Act of 1991.

The new FCC rules, effective January 1st, 2005, prohibit any person or entity including non-profit, tax-exempt associations, from sending an unsolicited advertisement to a fax machine. The only exception is where the recipient has signed a written consent form that clearly indicates the recipient's consent to receive facsimile ads from the sender.

Update

As of January 1st, 2005 the new rules requiring written consent before sending advertising faxes took effect. We need this information for our records, as we will be e-mailing and faxing newsletters, luncheon notices, etc. in the future.
